College-Age Program Agreement

I, the prospective student, certify that all of the information I am providing in this application is true and complete and that I have not omitted any factors that might alter MFSE's decision to partner with me. I understand that MFSE reserves the right to discontinue service for me and request that I remove myself from any host home MFSE has located, if it should be determined that I have not fully disclosed my background or if my behavior or character is judged by MFSE to be inappropriate for the host family or their situation. Should MFSE request that I remove myself from the host home with 30-day written notice, I shall comply with MFSE's notice and vacate the host home within 30 days.

I certify that I shall be fully responsible to meet all of the financial obligations on time that are assumed by this agreement. I shall, without invoice or reminder, provide the agreed upon stipend to the host family upon the day of my arrival and on that same day of every subsequent month or partial month thereafter until I have vacated the host home. I understand that failure to make timely payment is grounds for the termination of this agreement.

I, the student, shall not sublet my homestay to another student. MFSE is entitled to collect its fee from any subsequent student placed in the host home.

MFSE shall, if requested herein, locate an appropriate host family given the student's criteria as requested above. MFSE will interview and perform background and criminal history checks prior to approving any family to host a student. Following our screening process, MFSE will provide the host family with orientation and training.

MFSE makes no guarantee that the host family, however well-matched to the student's criteria on paper, will, in fact, meet with the student's satisfaction at all times. MFSE will provide one host family, should the student desire to move to a new family or if the family or agency requests the removal of the student, MFSE will require additional fees to relocate the student.

MFSE shall, if requested, attempt to mediate any disputes between host family and student via telephone for up to a period of 1 academic semester following the student's entry into the home we have recommended.

MFSE shall, if requested herein, assist with the application process to one or more of the schools we serve and help the student to acquire and meet the criteria for the issuance of the I-20.

MFSE shall, if requested herein, make application for health insurance for the student. MFSE can make no guarantee that any insurance company will actually underwrite the student. If MFSE is unable to obtain underwriting, ultimately it is the student's own responsibility to obtain his/her own health insurance coverage. MFSE is prohibited by law from earning any money through the sale or issuance of insurance products, therefore, this is a service MFSE provides free of charge only for students who are employing MFSE in another capacity.

MFSE shall, if requested herein, provide certain transportation as a service for students who are employing MFSE in another capacity. When MFSE provides transportation, MFSE can make no guarantee that the student will arrive at his/her destination on time.

MFSE shall, if requested herein, provide safe storage of the student's personal belongings during time periods when the student is outside of the United States.

MFSE's responsibility is limited to the areas listed above. The student him/herself is responsible for all other aspects of his/her personal welfare while in the United States.
